Declaration of Responsibility

This declaration of conformity is issued under the sole responsibility of the manufacturer.

Object of the Declaration

R-PET food contact containers intended for packaging of refrigerated and ambient food products.

The packaging is fully traceable through product code, batch number and production records maintained by the manufacturer.

Compliance with Applicable Union Legislation

FIALOPLASTIKI's R-PET bottles are produced using the good manufacturing practices (GMP) by R-PET pellets and masterbatches (coloring and uv stabilizers).

According to our supplier's information R-PET pellets are manufactured only with monomers, other starting substances and additives that are authorized under regulation (EU) 2025/351. R-PET pellets are made from hot caustic washed and dried PET flakes originating from collective post PET containers and comply with:

- Regulation (EU) 2025/40 of the European Parliament and of the Council of 19 December 2024 on packaging and packaging waste, amending Regulation (EU) 2019/1020 and Directive (EU) 2019/904, and repealing Directive 94/62/EC.
- Regulation (EU) 2025/351 of 21 February 2025 amending Regulation (EU) No 10/2011 on plastic materials and articles intended to come into contact with food and amending Regulation (EC) No 2023/2006 on good manufacturing practice for materials and articles intended to come into contact with food.
- Commission Regulation (EU) 2024/3190 of 19 December 2024 on the use of bisphenol A (BPA) and other bisphenols and bisphenol derivatives with harmonised classification for specific hazardous properties in certain materials and articles intended to come into contact with food, amending Regulation (EU) No 10/2011 and repealing Regulation (EU) 2018/213.
- Regulation (EC) No. 1935/2004 on the European Regulation (EC) No. 1935/2004 on the European Parliament and Council of 27 October 2004 on materials and articles intended into contact with food.
- Regulation (EC) No. 1907/2006 of the European Parliament and Council of 18 December 2006 concerning the registration, evaluation, authorization, and restrictions of chemicals (REACH Regulation).

The following precautions should be respected by the final user:

- Storage conditions: It is recommended to store the R-PET bottles and jars at temperatures between -35°C and 35°C ,in a closed storage area free of odors and humidity and away from direct sunlight and UV light exposure, keeping them in their original packaging. The storage area must be clean and free of contamination or objects that could damage the packaging or the product upon contact.
- Shelf life of R-PET bottles and jars: 36 months from receipt when the product is stored under the above conditions.
- Do not fill the R-PET bottles with hot food or condition at a temperature higher than 40°C.
- R-PET bottles and jars are for single use only.
- Final users must check the technological suitability of the employed packing system. The packer should inform our company before using the R-PET bottles and jars with foods containing special components (additives and flavorings) or when particular characteristics of the food to be packed require further restrictions.
- Final users must determine the shelf life of their food products packed in R-PET bottles and jars.
- Final users are responsible for ensuring that the finished food package complies with applicable migration limits in the food itself under actual conditions of use. Furthermore, the food packer is responsible for verifying possible interactions of the products or their components with the foodstuffs (e.g. modification of odor, taste, consistency, migration etc.) which are to be checked prior to use and in function of the end-uses.

This declaration replaces all previous declarations for the same specification/ product.
It remains valid until a change in the legislation or new scientific information changes the legal status.
